## Call to order

The meeting was called to order at 6:00 PM.

# **Approval of the Minutes**

Marty made the motion to approve the January minutes with Tom seconding. All were in favor and the motion passed.

## **New Business**

James Bennar Resignation - Rick

James has resigned his position, effective immediately and according to the bylaws, it is up to the Board to fill the position and then a new Board member will be elected at the next election. Dave Sanderson would be willing to come back to the Board as Scheduling and Mike would take over Player Personnel. Dave is only willing to do one year so the permanent replacement would occur at the next league meeting/election. Tom proposed that we accept this proposal, Marty seconded. All were in favor and the motion passed.

In Memoriam - Tom Holder

When a player family member passes away, traditionally the Board sends a sympathy card. Marty is willing to own sending those.

Pitching Helmets - Tom Holder

Tom made a motion that all pitchers wear a pitching helmet or be behind the screen. The motion was seconded by Mike. Mike, Bob D., Bob G., Rick and Tom were all in favor. Marty opposed. Motion carries.

Commitment Line - Tom Holder

Tom proposed that the commitment line be moved to 25 feet from home plate. The motion was seconded by Marty. All were in favor so the motion passed.

Home Runs - Tom Holder

There is currently a two home-run limit per game per team. Tom would like to suggest changing this to a "one-up" rule instead. Once <u>each</u> team has two home runs, then both teams are allowed another home run. It will continue to "one-up". Bob D. recommended that this be held until the fall season and the Board agreed.

Self-Umpiring - Tom Holder

With the increase in umpire fees Tom believes that it is time to self-umpire. After discussion of the pros/cons the Board decided that there is not enough time to implement this for the upcoming seasons and will take this up again in the fall.

## **Old Business**

Advertising Advisory Committee - Mike Marlowe

Mike has a proposed budget of \$600 for advertising that would cover the creation of the ads and boosting it out to the community.

Andy Johnson Courage Award - Tom Holder

Tom still needs to work with Dave Sanderson to get the website updated with this award.

2024 Budget Items - Bob Dalziel

Bob has the input that he needs to create the 2024 budget.

Pinch Runners - Tom Holder

The question on the survey whether a player could run as many times as needed in a game but only once per inning. Due to the survey being split on allowing unlimited pinch running (see Addendum A), the rule will remain as it is and will be taken into consideration again in the fall.

## Finance & Registration - Bob Dalziel

The bank account looks good. Planning for this year is underway. There will be the need to purchase softballs this year and there is an increase in the fee for the umpires. The Board proposed \$90 for the summer season and Bob indicated that the budget could support that.

Bob recommends that the league get a post office box to use for any correspondence. He also recommends that when the EIN is received that the league move to a new bank with more branches

since FWB only has two branches. Tom made a motion to that affect. Mike seconded. All were in favor and the motion carried,

### **Manager of Web Services - Dave Sanderson**

Dave was not in attendance and did not submit an update.

## **Scheduling - Mike Marlow**
