# Approval of May 23, 2017 Minutes

Motion to approve the minutes via email was made by Steve, seconded by Duane with unanimous approval.

## **New Business:**

Board elections – Rick DuVall

Rick communicated with Chuck about the elections. He can do all the work requested without Zack's help. The election would be for director and then the assignment of the positions would be after the election at the discretion of the Commissioner.

## Bat verification – Rick DuVall

## General pool player protocol – Rick DuVall

There was a continued discussion from last month's meeting about the use of pool players when a team loses a player and that player will not be returning. Several ideas were proposed and based on that, Frank to write a proposed change to the rule and bring it to the Board for review and approval.
